THE MINOR AND PARENT OR GUARDIAN HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence of Releasees (as identified below) or otherwise, while in or upon Sea Life Park for any purpose including participating in the Event. The undersigned recognizes and understands that there are risks and dangers associated with participation in the Event that could cause severe bodily injury, disability and death. Further, the risks and dangers may be caused by the negligent failure to act of the Releasees and others. 2. THE PARENT AND/OR GUARDIAN hereby agrees to indemnify and save and hold harmless the Releasees and each of them from any loss, liability, damage or cost that may occur due in any manner or degree to the presence of the parent/guardian or the MINOR at Sea Life Park, or in any way while participating in the Event and whether caused by negligence of the Releasees or otherwise. The parent and/or guardian further recognize and agree they are executing this Waiver and Release of Liability and Indemnity Agreement on behalf of themselves and on behalf of the MINOR.

4. THE PARENT AND/OR GUARDIAN HEREBY agree that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, and is intended to be as broad and inclusive as is permitted by the law of the State of Hawaii and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
